DIRECTIONS FOR USE: Apply as a dilute spray, ensuring complete coverage, without excessive run-off. For concentrate spraying, adjust dilution rate accordingly.

Summerfruit	Brownrot	40g/100 litres of water. Use minimum of 800g/ha.	 A: Apply in a regular blossom programme from pink to shuck fall inclusive. Thereafter apply alternative non-DMI fungicides through until harvest. or B: Apply 2-3 sprays at 7-10 day intervals in the period prior to harvest. When using pre-harvest use alternative non-DMI fungicides earlier in the season.

Apply a maximum of 3 applications, preferably with non-DMI fungicides, as required over the pink to shuck fall period. Thereafter apply alternative non-DMI fungicides through until harvest.

Mixing: Add the required amount of Corona 250WG into the half-filled spray tank with agitation operating. Continue agitation during spraying and after a stoppage before recommencing spraying.

Application: Make sure that spray equipment is correctly calibrated. Ensure complete spray coverage for best results. Do not overspray.

Compatibility: Corona 250WG is compatible with most of the commonly used insecticides and fungicides, except alkaline materials such as Bordeaux mixture and lime sulphur.

Withholding Period: Summerfruit – 1 day

Resistance Management: Corona 250WG contains a **GROUP 3 FUNGICIDE** belonging to the DMI (SBI: Class 1) group of chemistry. Naturally occurring biotypes resistant to DMI fungicides are known to exist. Resistance to these fungicides could develop from excessive use.
