### Emergency procedures - 24-hour advice in an emergency only: 0800 734 607

Hazard	Response
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
Spill or leak	Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Collect spilled material and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	<b>Call the Fire Service: Dial 111.</b> Wear PVC protective clothing and breathing apparatus. Extinguish fires with water spray, fog or foam. During a fire toxic fumes may be released. Cool containers with flooding quantities of water until well after fire is out. Contain run-off. Keep non-involved persons away.

### First Aid

If swallowed	Rinse mouth with water. DO NOT induce vomiting. If any discomfort persists, seek medical advice. For advice, contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in eyes	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention if irritation persists.
If on skin	If skin or hair contact occurs, remove contaminated clothing and wash skin and hair with plenty of soap and water. Get medical attention if irritation occurs and persists.
If inhaled	Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth to nose. Get medical attention if symptoms develop.

<b>Storage</b>	Store in original container in a cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, animal feed, children and animals. Keep container sealed when not in use.
